

Rewards Program Rules: Rewards For Credit Cardholders Techcombank Everyday When Spending On Grab App

- **1. Promotion name:** Reward for Techcombank Everyday credit cardholders when spending on Grab App
- 2. Area (scope) of promotion: Nationwide
- **3. Form of promotion:** Free gift of goods or services accompanied by the purchase and sale of goods or provision of services
- **4. Promo period:** From **1 September 2025** to **30 September 2025** or until the end of the Budget, whichever comes first.
- **5. Promotional goods and services:** Payment by Techcombank Everyday credit card issued by Techcombank ("Bank Card") and goods and services provided on the Grab Mobile Application (hereinafter referred to as the Grab Application).
- **6. Goods and services used for promotion:** Give promotion code when paying for purchases at Grab App paid with Techcombank Everyday credit card issued by Techcombank.
- 7. Customers of the promotion program (eligible for the promotion): Customers are Techcombank Everyday credit cardholders issued by Techcombank and are valid during the promotion period. Applicable to Techcombank Everyday credit cards with BIN headings: 422076, 403280.

- **9. Total value of goods and services used for promotion:** 3,000,000 VND (in words: Three billion VND).
- 10. Content and Detailed Rules of the Promotion Program:
- **10.1** Contents of promotion:

Rewards per day for GrabBike / GrabCar / GrabFood

- Reward Discount Code ("Reward Code") applied all days of the week when paying with Techcombank Everyday credit card for GrabBike / GrabCar / GrabFood services on the Grab App.
 - TCB10: GrabBike 10,000 VND discount for minimum application of 20,000 VND
 - o TCB20: GrabCar VND 20,000 off minimum application of VND 40,000
 - o TCB30: GrabFood VND30,000 off minimum order of VND60,000
- Each Customer is entitled to enjoy the offer maximum once / service / day, and not more than 8 times / service / month (according to the Customer ID at Grab). The offer code is reused the next day.



- The number of incentives is limited for the day, so cardholders making early eligible transactions will be prioritized to enjoy the incentive.
- Total maximum 4.567 codes per day.
- The program may end when the budget is used up or the last day of the program, whichever comes earlier.

10.2 Application conditions:

- The promotion code for Customers only applies from 7h00-23h59 for GrabFood services and 0h00-23h59 for GrabBike / GrabCar services for all weekdays during the promotion period;
- The offer code cannot be converted into cash or refunded/paid in excess in any form under any circumstances. The offer cannot be 100% converted into Grab's Products and Services and cannot be transferred to others:
- The promotion code does not apply to tolls, ferries, stations and other costs other than freight (if any);
- Incentives calculated on the value of orders and cars (excluding order shipping fees and other surcharges).
- The promotion code only applies on the latest version of the Grab App.
- Customers may not receive the offer in case problems arise from the Online payment portal at Grab. In case of difficulties related to using the offer code, Customers contact Grab via the Help Center for support.
- Valid spending transactions are performed by main cardholders or sub-cardholders and must be actual purchases and sales transactions and allowed in accordance with Vietnamese law.
- Techcombank is only a card issuer to support payment transactions at Grab Application, not a service provider on Grab. These Services are provided by the respective providers under the conditions and terms specified by that provider. By accepting or receiving the service, Customer agrees to ensure and will keep Techcombank from being harmed by claims, lawsuits, trials, damages, losses, incurred costs or liabilities.
- Customers note that before making payment, they need to select the Rewards Code.
 Customers only make payment when Grab app shows the reward amount at the payment step.
- Transactions eligible for the Promotion do not include refunded, cancelled transactions and transactions related to fraud and fake.



- In case the Customer returns / exchanges the product after successful payment, the value of the incentive will not be refunded.
- or the meeting will not be retained.
- In case there is not enough number of customers enjoying the promotion per day, the remaining number will be accumulated into the next batches until the end of the program. The total number of the program will be adjusted accordingly according to the Budget and not exceed the Program's budget of VND 3,000,000,000
- Techcombank has the sole right to decide whether or not to apply this offer with other Techcombank offers implemented at the same time.

11. Rewards process, methods and procedures:

- Method of paying promotion: The promotion code is publicly announced according to this Regulation. Customers need to enter the promotion code or choose the promotion code at the promotion list when paying for Techcombank Everyday cards on the Grab App to enjoy the promotion.
- Techcombank has the right to automatically withdraw the preferential amount if it detects fraud or self-seeking acts of cardholders.
- The above reward process may be changed depending on Techcombank's decision from time to time and is published / announced on the official website of the Bank after completing the notification procedures to the competent state agency (if any).
