- 1. Name of trader implementing the promotion program: Vietnam Technological and Commercial Joint Stock Bank (hereinafter referred to as "Techcombank")
- 2. Promotion name: "Open credit card to receive miles"
- 3. Area (scope) of promotion: Nationwide
- **4.** Form of promotion: Free gift of goods or services accompanied by the purchase and sale of goods or provision of services.
- 5. **Promotion period:** From march 20, 2025 to june 20, 2025 or until the end of the Promotion budget (whichever comes first)
- 6. Promotional goods and services: Credit cards issued by Techcombank are valid during the program, including Vietnam Airlines Techcombank Visa Platinum, Vietnam Airlines Techcombank Visa Classic credit cards.
- 7. Goods and services used for promotion: Vietnam Airlines' Lotusmiles

8. Customers of the promotion program (subjects eligible for promotion):

During the program, customers fully meet the following conditions:

- (i) Customer is a member of Vietnam Airlines Titan / Gold / Platinum
- (ii) Customers scan QR Code attached to ads posted by VNA and / or successfully register the need to participate in the program on Landing page
- (iii) Individual customers have never been recorded information on the system by Techcombank; and have never opened an account; and have not participated in any transactions or services with Techcombank (New customers)
- (iv) Customers open a new payment account with Techcombank successfully
- (v) Customers issue and activate new credit cards (main cards) at Techcombank (under the types of cards specified in section 6 above);
- (vi) Customers activate Automatic Profitability Version 2.0 successfully;
- (vii) Customers meeting the spending conditions in section 10 below;
- 9. The total promotion does not exceed the total budget of the program of VND 2,777,500,000.

12. Content and Detailed Rules of the Promotion Program:

- **12.1.** Content of the program:
 - 12.1.1. During the promotion period, customers who satisfy the conditions of sections8 and 10 of the Program (according to customer ID at Techcombank) willonly be awarded miles once during the promotion period according to thispromotion program Rules
 - **12.1.2.** Conditions for considering the validity of the customer's current account in section 08 of this regulation:
 - (i) A current account is successfully opened when the customer receives an account opening notification and is recognized by the Techcombank system on the Techcombank Mobile application interface, has a customer ID and has a transactionable account (except for cases where the current account is blocked / temporarily locked / closed because Techcombank detects risks, discrepancies or abnormal signs between customer identification information or detects suspicious transactions during the customer's use of the current account during the promotion period...)

- **12.1.3.** A valid card transaction is one that satisfies the following conditions:
 - (i) Is a transaction to pay for goods and services with a Visa credit card specified in Section 6 of the Program issued by Techcombank and is still valid at the time of the promotion.
 - (ii) Is a successful transaction (not including the transactions listed at Point 12.1.3. This Regulation and transactions for payment of fees and interest of card services);
 - (iii) Transaction performed on the main card: is a successful transaction within the period corresponding to the conditions for enjoying promotion specified in section 8 above
- **12.1.4.** Invalid payment transactions are transactions that:
 - Returned, refunded, disputed or invalid payment transactions, or fake, or service goods taxes;
 - (ii) Transactions with signs of fraud, taking advantage of the program, transactions requested by Techcombank to verify on the grounds that the cardholder does not perform the transaction;
 - (iii) Techcombank has the right to request the cardholder to provide financial invoices and relevant documents to prove that the cardholder's transaction is valid. In case the cardholder cannot prove that the transaction is valid, the cardholder will not be entitled to the Program's Incentives.
 - (iv) Cash withdrawal and advance transactions at ATMs / POS; transactions of collecting fees and interests; transactions of automatic cancellation / refund (void / reversal) due to: (i) system errors, or (ii) Customers, or (iii) the 3rd party cancels the transaction; other allowed transactions do not include transactions specified in section 12.1.2;
 - (v) Transactions that the Bank suspects signs of profiteering, use of cards for the wrong purposes, violation of credit card conditions and terms / conditions, terms on opening and using services at clauses at Techcombank, risk management policies related to products, including but not limited to the following cases:
 - ✓ Customers perform fraudulent card transactions, fraudulent card transactions, payment transactions not arising from the purchase and sale of goods and provision of services (fictitious transactions at card accepting units...);

- ✓ Customers make transactions of agency nature, abusive transactions, fraudulent transactions (Example: payment for electricity bills / airline tickets / telecommunications charges...);
- Payment transactions for operating expenses not of a personal consumer nature;
- ✓ Transactions at merchants with the following merchant codes: MCC 7995 (gambling, betting), MCC 6211 (securities, financial investments), MCC 4829, 6051 (money transfer services), MCC 6011 (cash withdrawals).
- Payment transactions at some card acceptance points (POS/mPOS) in the list that Techcombank assesses that there are signs of profiteering and fraud based on abnormal behaviors, frequency and value of transactions. spending of customers in each period.
- **12.1.5.** Customers who meet the valid conditions first and have a valid transaction earlier will be prioritized. In case many Customers have the same time and satisfy the valid transaction conditions, the promotion will be continued and Techcombank will be the final decision-maker.
- **12.1.6.** In case Techcombank needs more information about the transaction as specified in this regulation, Techcombank will notify the Customer to provide documents / invoices to prove the transaction. Customers supplement valid documents / invoices for Techcombank by the time limit recorded in Techcombank's Notice. The provision of this document will be carried out at Techcombank's transaction location. In case the Customer supplements the document after the above time limit or the Customer does not provide adequate documents as required by Techcombank, the relevant transaction will be determined as ineligible transaction to enjoy promotion, and Techcombank has the right to refuse to award miles and / or withdraw miles paid by Techcombank.
- **12.1.7.** Credit card eligible for promotion according to this Rule of Customer is not locked / cancelled at the time of promotion review
- 12.1.8. Customers participating in the promotion program according to this Regulation will not enjoy incentives from other promotions to open new credit cards of Techcombank
- 12.1.9. The promotion period is determined as follows: See section 5

The time to record valid Bank Card transactions is as follows: From March 20, 2025 to July 20, 2025, the time is valid for each customer according to Techcombank's specific notice via Techcombank mobile phone / app.

- **12.1.10.** Each customer is entitled to the promotion maximum once in the whole program. Customers who satisfy valid transaction conditions in advance, will be considered for promotion first, considered in chronological order, until the number of offers of the whole program. However, do not exceed the total promotion budget of the program 2,777,500,000 VND.
- **12.1.11.** The program may end at the specified time or when the promotional gifts run out, depending on whichever comes first and will be announced on Techcombank's website (<u>https://techcombank.com</u>) after Techcombank has completed the notification procedures to the competent state agency in accordance with regulations.
