Implementing the promotion program Golf privileges for cardholders Techcombank Private international payment cards

- 1. Promotion name: privileges for Techcombank Private international payment cardholders when booking Golf services.
- 2. Area (scope) of promotion: Nationwide
- 3. Form of promotion: Free gift of goods or services accompanied by the purchase and sale of goods or provision of services.
- 4. Promo period: From October 26, 2024 to February 28, 2025.
- 5. Promotional goods and services: payment services using Techcombank Private international payment cards
- 6. Goods and services used for promotion: UrBox promotion code
- 7. Customers of the promotion program (eligible subjects):

Individual customers using Techcombank Private International Payment Card (6 leading numbers of the card 401148) Hereinafter referred to as "Banking Card"

10. Content and Detailed Rules of the Promotion Program:

10.1. Detail of promotion

- Rewards code UrBox 50% Service Fee – understood as Service Fee Package 1 play including: Greenfee, caddy fee, 1/2 cart at the Golf courses within the scope of program



- implementation specified in article 10.3. The specific playing fee at each golf course applies from time to time policy of the UrBox partner.
- Each Techcombank Private cardholder can enjoy up to 4 UrBox Rewards codes per 1 calendar month.
- Each voucher is applied for 1 payment for 1 play of 18 holes. Any form of combined payment from 2 plays or more will not be applied voucher.
- Reservation of Golf Service must be made via Hotline 24/7: Phone: 1800282831 and email: TCBPrivate@Urbox.vn ("Headphone"). Reservation requests via third-party websites/applications or directly with the Golf Course will not be eligible for discount.

10.2.Application conditions:

- Eligible Payers: All Customers who own a Techcombank Private Payment Card and use this card to pay Service Fee at the Golf Courses specified in Article 10.3.
- Payment channel: Online payment by Techcombank Private Payment Card at the Payment Link provided by the switchboard employee (CS).
- In case the Customer cancels the service after successful payment, the value of the discount will not be refunded. Techcombank has the right to refuse to pay the discount for these transactions.
- Customers only make payment when the UrBox system displays the preferential Service Fee exclusively for Techcombank Private Payment Cardholders. Techcombank is not responsible for the system's failure to display the preferential amount at the payment step.
- In case of arising any complaints / complaints from customers related to the problems of goods / services provided, how to apply UrBox takes full responsibility for handling.
- Transactions eligible for the incentive program do not include refunded or cancelled transactions that make the actual order value not guarantee the minimum order value eligible for incentives as prescribed, excluding transactions related to fraud and fake.
- Techcombank has the sole right to decide whether or not to apply this offer with other
 Techcombank offers implemented at the same time.

10.4. How to use the offer:

To enjoy the program's incentives, customers can book a golf schedule through the following steps:

- Step 1: Customers / PCRM of Techcombank contact via one of the following channels to 24/7: make appointment: Hotline Phone: 1800282831 and email: TCBPrivate@Urbox.vn ("Taller"): Information to provide includes: The Golf Course want to make a reservation, the date of play, the required playing time, Full name of the customer, Head BIN (6 first numbers) and the last 4 numbers and the name of the type of card the customer owns, the phone number of the cardholder for Urbox to check the remaining valid number of vouchers according to the policy cardholders are entitled to (this information is not required), phone number to receive booking information (or email in case the customer sends reservation information via email) and Fight information available Customer has registered with the ground (if any).
- Step 2: The switchboard checks customer information.
- Step 3: The switchboard checks the responsiveness of the Golf course and confirms playtime with the Golf course.



- Step 4: The switchboard contacts the customer to inform the ability to respond with accompanying information including: Service available, confirmation Customer agrees to order the service and conditions / surcharges (if any).
 - The switchboard will contact the customer up to 03 times to notify the response ability and accompanying information.
 - Step 4a: Contacting the customer failed, the switchboard sends an SMS to the contact phone number Customer informed the switchboard in step 1.
 - Step 4b: Contact customer successfully:
 - Step 4b.1: Service available (understanding is that the Golf Course has room, the program has preferential rate, Customers are valid to participate in the program), Customer confirms and agrees to book the service and the conditions / surcharges (if any). Customers are forwarded to step 5.
 - Step 4b.2: Service is not available (understood as In case the Golf course does not confirm the reservation or has run out of incentives) Customers are informed by the Consultant and advise customers on an alternative playing time / Golf course for customers to choose. After reaching an agreement on a new playing time schedule, the customer service switchboard similar to step 4b.1
- Step 5: Customers pay the cost of booking a golf course according to the booking confirmation
 - After receiving the payment link, customers pay Service fee (including Greenfee, caddy fee, 1/2 cart) as follows:
 - The switchboard provides an online payment link to customers via the program's email or from Urbox's OA account on the Zalo platform: Name of UrBox Premium Services (phone number: 0984128166) or UrBox Electronic Gifts, ensuring the correct matching of the amount of playing golf fees payable by Techcombank cardholders after discounts. The switchboard suggests customers to make payment with the informed card when booking. Urbox is responsible for the safety and security of customer's card payment.
 - The payment of the cost should be completed before the playtime so that the Customer has priority to use the preferential Service Fee and preferential rate. After the Customer makes a successful payment, the Call Center will check the ability to meet again, if it is still available, it will book it for the customer, if it is no longer available, it will advise other Play Hours. In case of failure to select a new Play Hour, the Call Center



will refund the Customer. Customers will receive a refund within 7-15 working days from the successful payment.

- Other arising expenses (cost of food and drink, furniture hire, etc.), customers pay directly at the Golf course according to the prices specified by each course.
- Step 6: Customer Service Center when Customer needs to change / cancel play schedule (if Customer needs).

10.5. Reservation and reservation time requirements

Customers must book a play schedule at least 24 hours before playing for playtime on weekdays and 48 hours before playtime for playtime on weekends (saturday, sunday, holidays, new year). If Customers book after the time specified above, in case the field is empty, the switchboard will still receive support for Customers to book the field.

10.6. Cancellation, absence and change of play schedule, playground

- Any change or cancellation of the playing schedule must be informed directly by the Customer via the Call Center according to the minimum refund time without charge before the playing time of each field and be confirmed by the Call Center.
- Any change in play schedule, playground or cancellation that does not follow the minimum time for no-fee refund before the playtime of each field has been confirmed by the Call Center or Customer does not arrive will be counted as one play per booked date.
- No refund or cancellation of the fee collection in bad weather conditions, except for force majeure cases under the Cooperation Contract between the 2 parties.

11. Process, method, and procedures for receiving rewards:

- Promotion payment method: The promotion code is managed by UrBox, valid customers are automatically applied the promotion code. 50% of the Golf Service Fee is directly deducted from Service Fee when Customers make payment. Accordingly, Service Fee Customers make payment is recorded on the invoice as an amount equal to the invoice value minus (-) the promotion value that Customers are entitled to.
- Techcombank has the right to automatically withdraw the preferential amount if it detects fraud or self-seeking acts of cardholders.
